The bid security shall be valid for 30 days beyond the validity period of the bid. Required date of bid security validity period has been indicated in standard bid document.

6.0 Bids will be opened at **14:00 pm** : **2077-08-12 (27th November, 2020)** in the presence of bidders or their authorized representatives who wish to attend at office of **Mugum Karmarong Rural Municipality**,

Office of The Rural Municipal Executive, Pulu, Mugu. Absence of bidder's representative in bid opening shall not obstruct the bid opening.

7. The Bidder must quote unit rates in figure and words for all items of the works described in the Bill of Quantities and shall enter corresponding Amount for each item. Bidder must produce total Bid price and enter in the BOQ as well as in Letter of bid.

8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
